

2021 PORT HOPE PUBLIC OPINION SURVEY

Executive Summary


Highlights

In June 2021, Fast Consulting conducted an annual public opinion survey with residents of the Municipality of Port Hope to monitor support for Cameco Corporation's local operations and gather perceptions regarding the corporation. The survey sample of 325 residents lets us say with a 95% level of certainty that overall results are within plus or minus 5.4% of what they would be if the entire adult population of the municipality were polled. Data was weighted according to Statistics Canada Census data to ensure the sample matched Port Hope's age-based population.

7 out of 10 "Very Aware" of Cameco's Port Hope Operations

- All respondents (100%) are at least somewhat aware of Cameco's Port Hope operations, with the majority (70%) being very aware of the company.
- Long-term tracking shows consistently high awareness of Cameco, with the majority of respondents "very aware" of the company's Port Hope operations.


Awareness of Port Hope Operations, 2015-2021



9 out of 10 Are Supportive of Cameco

- Nine out of ten (91%) Port Hope respondents support the continuation of Cameco's operations in Port Hope—with well over half (60%) saying they are "strongly supportive."
- Over the last 7 survey cycles, overall support for the continuation of Cameco's operations in Port Hope has held steady at 9 out of 10 respondents.

Economic Impact Remains #1 Driver of Public Support

- Over half (56%) of respondents who support the continuation of Cameco operating in Port Hope say it's because of Cameco's contribution to the economy, jobs and tax revenue.
- Approximately 21% are supportive because they believe the company is a good corporate citizen, 12% because they support nuclear/clean energy, 11% because Port Hope would suffer if the company left and 11% because they believe the company is safe and supportive.
- Among those not supportive of Cameco continuing to operate in Port Hope, the most frequently cited reasons are worries about environmental impact (8%), safety & health concerns (6%), perception of the operation destroying the waterfront (5%) and waste disposal/clean-up concerns (4%).

Environmental Impact Remains #1 Top-of-Mind Issue

- When thinking about Cameco in Port Hope, the issue people mention most frequently is the company's environmental impact, at 28% (down from 35% in 2020 and 41% in 2019).
- The remaining top 5 most frequently mentioned issues are community safety (24%), waste management (16%), jobs (13%) and workplace safety (13%).

9 out of 10 Are Knowledgeable about Cameco

Consistent with previous surveys, the large majority (93%) of Port Hope respondents describe themselves as knowledgeable about Cameco, including 37% who say they are "very knowledgeable."

Majority Have No Specific Concerns about Cameco

Most respondents (72%) do not have any specific concerns about Cameco's operations in Port Hope. The most frequently mentioned concerns are: 8% think the operation is destroying the waterfront (unchanged from 2020), 6% are concerned about waste management/clean-up (vs. 13% in 2020), 5% are worried about the environmental impact (vs. 7% in 2020) and 5% are concerned about leaks/water contamination/ dumping (vs. no mentions in 2020, in line with 5% in 2019).

9 out of 10 Aware of Nuclear Energy's Role in Ontario

- > 90% of respondents are aware nuclear energy provides more than half of the electricity generated in Ontario, including 65% who are "very aware."
- > 88% are aware nuclear reactors are a low carbon emitting source of electricity that is increasingly seen as part of the solution to climate change, including 70% "very aware."
- > 86% are aware all nuclear reactors in Ontario use uranium processed by Cameco in Port Hope, including 62% "very aware."

Most Comfortable with Nuclear Operation in Port Hope

- Consistent with the long-term trend, the majority appear comfortable with Cameco operating in Port Hope:
 - 93% agree that Port Hope is a safe and healthy place to live, including 74% "strongly agree."
 - 87% agree that regulators adequately ensure the safety of Port Hope residents, including 57% "strongly agree."
 - 85% agree that Cameco does everything possible to protect people and environment, including 52% "strongly agree."

2021 Trust Index Scores

Although Cameco receives operating licenses from federal and provincial regulatory bodies, to remain viable the company also needs a social licence to operate from the communities in which it exists. The Trust Index (TI) calculates overall public support for Cameco in Port Hope based on public perceptions of the company's performance in terms of environmental responsibility, internal processes and community citizenship. Respondents are asked to rate their agreement (or trust) with a series of statements using a scale of 1 to 10, with 10 being totally agree.

- 2021 Trust Index measures are down from 2020 but remain in the "very good to excellent" range:
 - o Internal processes: 8.01 vs. 8.20 in 2020; 8.04 in 2019
 - o Community citizenship: 8.03 vs. 8.21 in 2020; 8.02 in 2019
 - Environmental responsibility: 7.44 vs. 7.51 in 2020; 7.40 in 2019
- Consistent with the 2020 survey, three of the highest trust scores fall in the community citizenship category. *Cameco Corporation is a supporter of the Port Hope community* (8.66), a creator of quality employment in Port Hope (8.46), a generator of economic opportunity in Port Hope (8.30).

Vision in Motion

- Nearly all respondents (99%) are aware of the federal government's Port Hope Area Initiative (PHAI) to cleanup and manage low-level radioactive waste in Port Hope. Half (54%) are aware of Cameco's Vision in Motion plan, and the majority of these respondents (70%) are aware it is separate and distinct from PHAI.
- Nine out of ten (90%) respondents agree Vision in Motion is a step in the right direction and benefit for the community; 92% agree the Vision in Motion plan to turn over waterfront land in the harbour area for public use is a benefit for the community.

8 out of 10 Think Cameco Makes Information Readily Available

- È Eight out of ten (82%) respondents agree Cameco makes information about its operations in Port Hope readily available to residents; 92% are aware Cameco regularly participates with the public through community events where residents can get information about Cameco and its operations.
- > Seven out of ten (73%) respondents recall receiving a newsletter from Cameco; 92% of them read the newsletters.

9 out of 10 Aware Cameco Invests in Port Hope

Nine out of ten (93%) respondents were aware, prior to the survey, that Cameco invests in the Port Hope area through sponsorships and other community initiatives.

Methodology

In June 2021, our firm conducted a public opinion survey with residents of the Municipality of Port Hope to monitor support for and gather perceptions of Cameco's operations in that community.

The 2021 survey includes 325 Port Hope and area residents and was done by landline and mobile telephone. Landline respondents were selected from a randomly generated electronic sample frame built by Fast Consulting and ASDE. Elemental Research of Ottawa assisted with the mobile telephone portion. The survey is conducted annually and includes baseline questions asked in previous years, enabling us to monitor public opinion and perceptions over time.

The survey was programmed into a CATI (Computer Assisted Telephone Interviewing) survey platform. It was pre-tested to ensure it flowed efficiently and incorporated correct branching and skip patterns. Surveys were conducted by experienced public opinion interviewers.

The survey sample frame is constructed to obtain interviews from a random selection of households in the Municipality of Port Hope, which consists of two wards. Ward 1 is the urban sector with the majority of commercial and industrial development. It was the former Town of Port Hope prior to amalgamation in 2001. Ward 2 is the former Hope Township and consists of several hamlets including Welcome, Campbellcroft, Garden Hill and Perrytown.

The overall margin of error for a probability-based telephone survey with a random sample of 325 respondents is +/- 5.4%, with a 95% confidence interval (19 times out of 20). Margins of error are greater for smaller sub-groups.

Survey Results

Awareness of Cameco

Q. We're interested in your opinion regarding a company called Cameco Corporation, a nuclear energy company that operates two facilities in Port Hope. The Port Hope conversion facility processes uranium that is used to generate clean electricity here in Canada and around the world. Cameco Fuel Manufacturing manufactures nuclear fuel bundles and other component parts for the Canadian-designed Candu nuclear reactors. How aware area you of Cameco's Port Hope operations?




 All respondents (100%) are at least somewhat aware of Cameco's Port Hope operations, with the majority (70%) being very aware.

- Virtually all respondents across age and gender groups are at least somewhat aware of Cameco's Port Hope operations. Young people ages 18-34 are least likely to be "very aware" and ages 35-54 are most likely.
- Long-term tracking shows consistently high awareness of Cameco, with the majority of respondents saying they are very aware of the company's Port Hope operations.


Awareness of Port Hope Operations, 2004 - 2021



Important Issues

- Q. What types of issues are important to you when you think about Cameco in Port Hope?
- When people are asked to think about Cameco in Port Hope, the issue they mention most frequently is the company's environmental impact, at 28% (down from 35% in 2020 and 41% in 2019).
- The remaining top 5 most frequently mentioned issues are:
 - o community safety (24%, unchanged from 2020)
 - waste management (16%, down from 22% a year ago)
 - o jobs (13%, down from vs. 28% in 2020)
 - o workplace safety (13%, up from 9% in 2020)
- One in ten mention reclamation/clean-up plans (12% vs. 5% a year ago) and being open and transparent (12% vs. 10% a year ago).
- Other mentions include community support (11% vs. 18% in 2020), economic diversification/tax revenue (9% vs. 11% in 2020) and health concerns (9%). These mentions are in line with previous years.
- Young people ages 18-34 are more likely than older respondents to cite environmental impact, being open & transparent and nuclear as a clean source of energy.


Environmental Impact Remains #1 Top-of-Mind Issue


• Nine out of ten (91%) Port Hope respondents support the continuation of Cameco's operations in Port Hope—with over half (60%) saying they are "strongly supportive."

- Nine out of ten respondents across age and gender groups support the continuation of Cameco's Port Hope operations. Men and ages 35-54 are more likely to be "strongly supportive"; women and young people ages 18-34 are more likely to be "somewhat supportive."
- Over the last 7 survey cycles, overall support for the continuation of Cameco's operations in Port Hope has held steady at 9 out of 10 respondents.


Support for Cameco's Port Hope Operations, 2004 - 2021



Reasons for Support

- Q. What would you say is the main reason you are supportive or not supportive of Cameco continuing to operate its facilities in Port Hope?
- Over half (56%) of respondents who support the continuation of Cameco operating in Port Hope say it's because of Cameco's contribution to the economy, jobs and tax revenue. This is consistently the number one reason residents support Cameco.
- Approximately 21% are supportive because they believe the company is a good corporate citizen, 12% because they support nuclear/clean energy, 11% because Port Hope would suffer if the company left and 11% because they believe the company is safe and supportive.
- Among those not supportive of Cameco continuing to operate in Port Hope, the most frequently cited reasons are worries about the environmental impact (8%), safety & health concerns (6%), the perception that the operation is destroying the waterfront (5%) and waste disposal/clean-up concerns (4%).
- Cameco's contribution to the Port Hope economy, jobs and tax revenue is the number one reason respondents across age and gender groups support Cameco. The number two reason is that the company is seen as a good corporate citizen.

Economic Impact Remains #1 Driver of Public Support




Perception of Support

- Q. What about others in your community, would you say that most people in Port Hope are supportive or not supportive of the continuation of Cameco's operations in Port Hope?
- Eight out of ten (80%) respondents think others in their community are at least somewhat supportive of the continuation of Cameco's operations in Port Hope.
- Consistent with the long-term trend, respondents continue to underestimate support for Cameco. The largest gap between actual and perceived support is in the strongly supportive category—in 2021, 60% of respondents are strongly supportive of Cameco operating in Port Hope, while 30% think others in the community are strongly supportive. The general perception is that most Port Hope residents are somewhat supportive.

People Continue to Underestimate Support for Cameco




Gap Between Perceived vs. Actual Support, 2004 - 2021

Q. Would you describe yourself as being very knowledgeable, somewhat knowledgeable or not really knowledgeable at all about Cameco?




 Consistent with previous surveys, the large majority (93%) of Port Hope respondents describe themselves as knowledgeable about Cameco, including 37% who describe themselves as "very knowledgeable" and 56% "somewhat knowledgeable."

- While the large majority of respondents across age and gender groups are knowledgeable about Cameco, most describe themselves as somewhat knowledgeable.
- Since respondents were first asked this question in 2007, nine out of 10 have consistently self-described as knowledgeable about Cameco.


Knowledgeable about Cameco, 2007 - 2021



Specific Concerns

- Q. Do you have any specific concerns with the presence of Cameco's operations in Port Hope?
- Consistent with previous surveys, most respondents (72%) do not have specific concerns with Cameco's operations in Port Hope.
- The most frequently mentioned concerns are generally consistent from year to year:
 - 8% think the operation is destroying the waterfront, unchanged from 2020
 - 6% are concerned about waste management/clean-up, down from 13% in 2020
 - 5% are worried about the environmental impact (vs. 7% in 2020)
 - 5% are concerned about leaks/water contamination/ dumping (vs. no mentions in 2020, in line with 5% in 2019).
- Another 4% do not have any concerns as long as Cameco follows safeguards.

Awareness of Nuclear Energy

Role of Nuclear Energy in Ontario

- Q. Would you say you are very aware, somewhat aware or not aware that nuclear energy provides more than 50% of the electricity generated in Ontario?
- 90% of respondents indicate they are aware that nuclear energy provides more than half of the electricity generated in Ontario including 65% who are "very aware" (up from 53% "very aware" in 2020).


Nuclear Energy and Climate Change

- Q. Would you say you are very aware, somewhat aware or not aware that nuclear reactors are a low carbon emitting source of electricity that is increasingly seen as part of the solution to climate change?
- 88% indicate they are aware that nuclear reactors are a low carbon emitting source of electricity that is increasingly seen as part of the solution to climate change—including 70% who describe themselves as are "very aware" (up from 59% "very aware" in 2020).


Role of Port Hope in Uranium Processing

- Q. Would you say you are very aware, somewhat aware or not aware that all nuclear reactors in Ontario use uranium processed by Cameco in Port Hope?
- 86% of respondents exhibit awareness that all nuclear reactors in Ontario use uranium processed by Cameco in Port Hope, including 62% who say they are "very aware" (up from 52% "very aware" in 2020).


9 out of 10 Aware Nuclear Energy Supplies Ontario Electricity




9 out of 10 Aware Ontario Reactors Use Port Hope Uranium




 Nine out of 10 respondents (85%) agree that Cameco does everything possible to protect people and the environment including half (52%) who "strongly agree."


- The large majority of respondents across age and gender groups agree Cameco does everything possible to protect people and the environment.

Q. Do you agree that Port Hope is a safe and healthy place to live?






- The large majority of respondents across age and gender groups agree Port Hope is a safe and healthy place to live.

Perception of Regulatory Safety

Q. Do you agree that various regulators adequately ensure the safety of Port Hope?




 Nine out of ten (87%) respondents agree that regulators adequately ensure the safety of Port Hope residents, including over half (54%) who "strongly agree." This is up somewhat from previous surveys.

- The large majority of respondents across age and gender groups agree that various regulators adequately ensure the safety of Port Hope residents. Young people appear to have more confidence in regulatory organizations, as ages 18-34 are generally more likely to "strongly agree" with this statement.
- The percentage of respondents who agree that regulators adequately ensure the safety of Port Hope residents has increased over time since 2006.

Trust Index

Although corporations like Cameco receive their operating licenses from various federal and provincial regulatory bodies, they also need a social licence to operate from the communities in which they exist.

The Trust Index (TI) calculates overall public support for Cameco in Port Hope based on the integration of public perceptions and opinions regarding the company in terms of its environmental responsibility, internal processes and community citizenship. Taken together, these form a trust index—a key aspect of measuring public support for Cameco and its operations in Port Hope.

Respondents are asked to rate their level of agreement (or trust) to a series of statements on a scale of 1 to 10. We recommend interpreting ratings in the 1 to 4 range as "in need of improvement," ratings in the 5 to 6 range as "satisfactory" and ratings in the 7 to 10 range as "very good to excellent."

Increase in 2021 Trust Index Scores

- 2021 Trust Index measures are down from 2020 but remain in the "very good to excellent" range:
 - Community citizenship: 8.03 vs. 8.21 in 2020 and 8.02 in 2019
 - Internal processes: 8.01 vs. 8.20 in 2020 and 8.04 in 2019
 - Environmental responsibility: 7.44 vs. 7.51 in 2020 and
 7.40 in 2019


Vision in Motion

- Q. Are you aware that the Government of Canada has embarked on cleanup and management of historic low-level radioactive waste in Port Hope, called the Port Hope Area Initiative?
- 99% of respondents are aware of the federal government's Port Hope Area Initiative (PHAI) to cleanup and manage low-level radioactive waste in Port Hope.
- Awareness of the PHAI is high across age and gender groups.
- Q. Are you aware of Cameco's Vision in Motion plan?
- Over half (54%) of respondents are aware of Cameco's Vision in Motion plan, consistent with previous years.
- Ages 35-54 are the most likely to be aware of the Vision in Motion plan.

99% Aware of Port Hope Area Initiative








Tracking Awareness of PHAI and Vision in Motion, 2017 - 2021





- Respondents like to use multiple media channels to get information about local current events. Approximately half (47%) get their news from local newspapers, 33% from websites, 28% from Port Hope social media groups, 20% by word of mouth and 17% from community emails.
- Younger respondents are more likely to prefer receiving information about local current events from websites and local social media groups. Ages 18-34 are also more likely to use word of mouth. And while older respondents 55+ are the most likely to turn to local newspapers, young people ages 18-34 are not far behind.
- Men are more likely to turn to local newspapers and word of mouth for local current events; women are more likely to turn to websites and Port Hope social media groups.





Cameco Newsletter Recall & Readership, 2007 - 2021






2021 PORT HOPE PUBLIC OPINION SURVEY


